Minutes – Approval of:

Regular Board Meeting Minutes: March 20, 2018: No additions or corrections. Trustee Ladislas moved to approve minutes, seconded, all in favor, none opposed. Motion carried.

There will be staff schedule adjustments in May following staff member Cheryl Delorto’s resignation announcement. Library will be closed on a Friday in May, TBA, to install new lighting. There will be an In-House Staff teaching meeting that day. Library has been awarded 2018 Per-Capita Grant money. Waiting to receive 2017 Per- Capita Grant money. Kaitlyn Boyle awarded “Spanish and English Speakers Unite” \$1,500. Grant.

RAILS News: Informed by State they will be receiving 2019 funding. Beta testing for “Find More Illinois” has begun, patrons can now go online to find a book from across the State. Still working on Museum Program, having difficulties getting businesses on board to become sponsors.

LIBRARY BUILDING: George Johnson (Maintenance) agreed to be present on day new lighting will be installed to observe installation by ComEd Energy Lighting Project/ Dominion Lighting. ComEd in process of determining how many lights will be needed. Currently they are working on Oak Forest Acorn Library. The price is going down. Dimming is by phone APP. Director Bormet will be getting a phone to control lighting only. Waiting for a date to schedule installation of new lighting- must know date three weeks in advance to schedule staff.
